* & **: The State changed tax calculations on certain levies in regards to the 10% and 2 1/2% rollbacks. In order to estimate/ calculate taxes, use the value in the * column for what used to be 10% rollback (on all res/ag) and now is the non-business credit and the ** for the 2 1/2 owner occupied (if applicable). The new formula is:

Step 1: Market Value x 35% = Assessed Value

Step 2: (Assessed Value x Effective Rate) divided by 1000 = Gross Annual Tax

Step 3: (Gross Annual Tax x Non-business*) + (Gross Annual Tax x Owner Occup) = Total Rollback**

Step 4: Gross Annual Tax - Total Rollback = Net Annual Tax
